

**STERLING UBER SWEEPSTAKES**

**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING. NO ALCOHOLIC BEVERAGES ARE INCLUDED IN THE PRIZE(S).**

- ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the 50 United States, excluding Utah, and the District of Columbia who are at least 21 years of age at the time of entry (“Entrant”). All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned. For purposes of the Sweepstakes, an Entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of entry. Entrants will not be allowed to change their physical addresses or e-mail addresses.

**3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period an Entrant may enter the Sweepstakes as set forth below:

**A. Text Message:** Using an SMS-enabled mobile device, an eligible Entrant may send a text message to the short code "87654" ("Short Code") along with the keyword "STERLING" ("Keyword"). Once a valid text message is received, the Entrant will be sent a follow up text message requesting his/her date of birth. Upon submission of a valid date of birth, the Entrant will be sent another request for his/her e-mail address and affirmation that he/she agrees to these Official Rules. Upon submission of a valid e-mail address, the Entrant will receive an entry into the applicable Entry Period and will be sent a confirmation text message. NOTE: Confirmation text message is not proof of entry. Proof of text message submission does not constitute proof of delivery or receipt of the text message.

**IMPORTANT: Message and data rates may apply for each text message sent or received.** Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless provider's pricing plans. By texting the Short Code, you are providing your signed consent to receive autodialed text messages. Consent to receive text messages is not required or a condition of any purchase. **B. Online:** An eligible Entrant may visit <https://www.sterlingvineyards.com/UBER> ("Website") and complete and submit the online registration form in order to receive one (1) entry into the applicable Entry Period. The Entrant will first be required to confirm he/she is twenty-one (21) years of age or older and enter his/her valid e-mail address. The Entrant must then complete the registration form, which may include, but is not limited to, his/her complete first and last name (no initials), street address (no P.O. box), city, state, ZIP code, phone number, date of birth, and agreement to these Official Rules. After completing registration, an Entrant may return daily and enter his/her age and valid e-mail address to receive an entry into the Sweepstakes.

**Entry Limit:** Regardless of the method of entry used, there is a limit of one (1) entry per person/e-mail address per Entry Period. If more than one (1) entry is received from the same person/e-mail address during the same Entry Period, only the first entry received may be considered valid.

- 4. RANDOM DRAWING:** On or about each Drawing Date for Entry Periods 1 – 60 listed in Section 1, Administrator will select one hundred forty-seven (147) potential prize winners from among all eligible entries received during the applicable Entry Period; on or about the Drawing Date for Entry Period 61 listed in Section 1, Administrator will select two hundred two (202) potential prize winners from among all eligible entries received during Entry Period 61. Each winner is deemed a potential winner, pending verification of the Entrant’s eligibility and compliance with these Official Rules, as determined by Sponsor or Administrator, in their sole and absolute discretion.
- 5. PRIZES, APPROXIMATE RETAIL VALUE (“ARV”), AND ODDS OF WINNING:**
- A. Prizes (9,022 total; 147 per Entry Period 1 – 60 and 202 for Entry Period 61):** The prize is a one (1)-time use \$10 Uber credit (“Prize”). No more than nine thousand twenty-two (9,022) total Prizes will be awarded (one hundred forty-seven [147] per Entry Period 1 – 60 and two hundred two [202] for Entry Period 61). The ARV of each Prize is \$10.
- B. Prize Terms:** To use a Prize, winner must access his/her Uber account in the Uber App (or download the Uber App and create an account, at no charge) and enter the Prize as instructed in the Uber App to apply a promo code to his/her Uber account. After winner has entered the code, the Prize will be added directly to his/her Uber account and will apply to one (1) ride when requested via the Uber App. Participant is responsible for any portion of the ride fair that exceeds the amount of the Prize. A Prize may only be applied towards one (1) ride, and any balance left after one (1) ride will not be retained by a winner. **Prizes expire on June 30, 2019.** Prizes subject to Uber terms and conditions. Sponsor reserves the right to substitute a prize of equal or greater value in case of unavailability of the Prizes or force majeure. Prizes are non-transferrable and may not be bought, bartered, or sold. Prizes are void and will be rejected if not obtained in accordance with these Official Rules. If a Prize contains printing, typographical, mechanical, or other errors, Sponsor’s sole liability is limited to replacement with another Prize, while supplies last.
- C. Total ARV:** The ARV of all Prizes in this Sweepstakes is \$90,220.
- D. Odds of Winning:** The odds of winning a Prize depend upon the number of eligible entries received into each Entry Period.
- E. Prize Limit:** Limit one (1) Prize per person/household for the entire Sweepstakes.
- 6. HOW TO CLAIM A PRIZE:** Each potential winner who entered via the Website will be notified via e-mail, at the e-mail address provided at registration, by Sponsor or its authorized designee with a link to the redemption portal. Each potential winner who entered via text message will be notified via text message, at the phone number used to enter the Sweepstakes, by Sponsor or its authorized designee with a link to the redemption portal. A potential winner must visit the redemption portal and follow the instructions to redeem a Prize at the redemption website by 11:59:59 PM ET on July 7, 2018. If a potential winner is disqualified, is found to be ineligible, is not in compliance with these Official Rules, declines to accept a Prize, or does not redeem the Prize within the time limit specified, the Sponsor may, in its sole discretion, conduct a random drawing to select an alternate winner from the remaining eligible entries. THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN CALIFORNIA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN NAPA COUNTY, CALIFORNIA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR SWEEPSTAKES ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
